FREIGHT

All orders are shipped FOB factory/warehouse, except as expressly provided below. When delivered to the Transportation Company, the Purchaser assumes the risk of loss or damage in transit.

Customer orders with net product value in excess of \$7,000.00 will be shipped prepaid by the ASSA ABLOY ACCENTRA® carrier of choice to a single destination point in the United States.

Customer orders with net product value less than \$7,000.00 will be shipped prepaid by the ASSA ABLOY ACCENTRA® carrier of choice and freight and handling charges will be added to the customer's invoice.

A minimum freight and handling charge of \$15.00 will be charged on orders with net product value of \$400.00 or less. The minimum freight and handling charge will not apply to orders for only Cut (bitted) keys of any type, Master keys, Master keyed cylinders or padlocks and factory generated bitting lists that do not have any other product types included on the order. Freight on these orders will be charged as the percentage of invoice value.

For orders with net product value greater than \$400.00 and less than \$7,000.00, freight charges will be calculated as a percentage of the net invoice value and will be added to Customer's invoice. The percentage is based on the National U.S. Average On Highway Diesel Fuel Prices as reported by the US Department of Energy in effect at the beginning of each quarter. On the first Monday of each quarter, the new rate will be published on the ASSA ABLOY ACCENTRA® and Door Security Solutions extranet and

will go into effect on the 2nd Monday of the quarter. Please refer to the ASSA ABLOY ACCENTRA® distributor

extranet for the rate chart and information on the current freight charge percentage. The percentage in effect at the time of shipment of the order will be charged.

Great Grand Master keys, Grand Master keys, Master keys, Construction Master keys, Control Keys, and Change Keys which are shipped separate from customer order for security reasons, on orders with total net product value in excess of \$7,000.00 will be shipped prepaid by the ASSA ABLOY ACCENTRA® carrier of choice. If the total order value is less than \$7,000.00, the shipping charges will be added to the Customer's invoice.

If a customer provides their own freight account number for the freight charges, ASSA ABLOY ACCENTRA® will apply a handling fee of \$25.00 to the invoice.

Expedited shipping options – If the customer requests an expedited method of shipping such as "Next Day Air" the charges will be prepaid by ASSA ABLOY ACCENTRA® and the full rate of the service, as published by the carrier, will be added to the customer's invoice.

Packing – ASSA ABLOY ACCENTRA® will pack, mark and ship the products according to its standard procedures for shipment, unless the parties agree, in writing, that ASSA ABLOY ACCENTRA® will comply with any special instructions provided by the customer. Special instructions must be submitted, in writing, at time of order placement. Compliance with special instructions may result in an increased price.

EXPORT CONTROL AND SANCTIONS

1.1 The Customer represents and warrants to ASSA ABLOY ACCENTRA® that it will always act in compliance with Economic Sanctions and Export Control Laws, and that:

- a) neither the Customer, its affiliates, or any of their respective directors, officers, employees nor, so far as the Customer is aware, any agents or other persons acting on behalf of any of the foregoing:
 - I. is, or has been, a Listed Person;
 - II. has engaged in any business dealings or activities that would reasonably be expected to result in it becoming a Listed Person;
 - III. directly or indirectly, has conducted or is conducting any business dealings or activities with or for the benefit of, or is otherwise involved in any business with a Listed Person, or otherwise acting in violation of Economic Sanctions and Export Control Laws;
 - IV. has engaged or is engaging in any transaction that circumvents, evades or avoids, or has the purpose or effect of circumventing, evading or avoiding, or attempts to violate, any Economic Sanctions and Export Control Laws; or
 - V. is, or has been, in violation of, or subject to, any investigation or enquiry by, or on behalf of, any governmental or other regulatory body relating to Economic Sanctions and Export Control Laws.
- b) the Customer shall act in compliance with Economic Sanctions and Export Control Laws, and shall not sell nor re-export the Product without all requisite licenses and approvals under Economic Sanctions and Export Control Laws;
- c) the Customer shall not sell, export or re-export, the Product, directly or indirectly, to the Russian Federation or Belarus or for use in the Russian Federation or Belarus (whether or not permitted under Economic Sanctions and Export Control Laws applicable to the Customer);
- d) the Customer shall undertake its best efforts to ensure that the purpose of this Clause is not frustrated by any third parties further down the commercial chain, including by possible resellers;
- e) the Customer agrees to (i) cascade the contractual obligations set forth in this Section 1.1. in contracts with third parties, including possible resellers, further down the commercial chain.; and (ii) set up and maintain an adequate monitoring mechanism to detect conduct by any third parties further down the commercial chain, including by possible resellers, that would frustrate the purpose of this Section 1.1;
- f) the representations and warranties set forth in this Section 1.1 above shall always remain true and correct;
- g) the Customer will provide written notice to ASSA ABLOY ACCENTRA® as promptly as possible and in any event within five business days, if (i) any representation or warranty should cease to be true at any time., or (ii) the Customer should encounter any problems in applying paragraphs b)- e) in this Section 1.1 above, including any relevant activities by third parties that could frustrate the purpose of said paragraphs b)- e); and
- h) the Customer will not engage in any transaction for Military End-Use unless explicitly approved in writing by ASSA ABLOY ACCENTRA®.

The Customer will provide all information relating to requests for Products that the Customer suspects could violate or circumvent Economic Sanctions and Export Control Laws, including requests from or on behalf of a Listed Person, and other attempts to acquire ASSA ABLOY ACCENTRA® products in violation of Economic Sanctions and Export Control Laws. The Customer will, to the best of its abilities, cooperate with ASSA ABLOY ACCENTRA® to facilitate compliance with Economic Sanctions and Export Control Laws and will upon ASSA ABLOY ACCENTRA®'s request provide ASSA ABLOY ACCENTRA® with

true, complete and correct copies of all documentation relating to any business dealings involving the Product, including but not limited to, end-user certifications, information concerning compliance with the obligations under above paragraphs b)- e) in this Section 1.1, and other information as may be required by ASSA ABLOY ACCENTRA® within two weeks of the simple request of such information.

1.2 ASSA ABLOY ACCENTRA® shall not be obliged to make any payment or take any other action if ASSA ABLOY ACCENTRA® believes in good faith that such action may constitute a violation, contribute to a violation, or constitute a circumvention of any Economic Sanctions and Export Control Laws.

1.3 This agreement may be terminated immediately by ASSA ABLOY ACCENTRA® by written notice to the Customer if:

- (a) the Customer fails to provide any notice required under this Section 1.1 above, or should ASSA ABLOY ACCENTRA® determine, in its sole discretion, that any representation or warranty set forth in Section 1.1 above has failed to be true and correct at any time;
- (b) the Customer has misrepresented or failed to properly disclose any material fact, or to provide any documentation, certifications or information requested by ASSA ABLOY ACCENTRA®; or,
- (c) either party's ability to fulfil an obligation under this agreement is materially affected by the imposition of restrictions in Economic Sanctions and Export Control Laws.

1.4 Upon any such termination, this agreement and all rights and obligations hereunder shall immediately terminate, provided that the Customer shall remain liable to ASSA ABLOY ACCENTRA® for any breach of its obligations hereunder. 1.5 The Customer shall indemnify ASSA ABLOY ACCENTRA® and its affiliates, directors, officers, employees, advisors, agents and holders of its equity interests (collectively, "Indemnitees") against, and shall hold each Indemnitee harmless from, any and all third party claims, damages and liabilities, including the reasonable fees, charges and disbursements of counsel, incurred by or asserted against any Indemnitee arising out of, in connection with, or as a result of (a) any representation or warranty set forth in Section 1.1 above not being true and correct when made, (b) any breach by the Supplier of any obligation under Section 1.1 or 1.2 above, or (c) any claim, litigation, investigation or proceeding relating to any of the foregoing, whether based on contract, tort or any other theory. This indemnity shall survive the termination of this agreement indefinitely.

For the purposes of this part of the agreement under the heading "Export Control and Sanctions",

"Economic Sanctions and Export Control Laws" means all economic sanctions and export control laws, regulations, rules or restrictive measures, including but not limited to import and export restrictions on materials, intellectual property, other intangible personal property, services, items and transactions, adopted and enforced by governmental authorities of Canada, the EU, UK, UN, USA or any other relevant governmental or regulatory authority, applicable to the ASSA ABLOY ACCENTRA® or the Customer.

"Listed Person" means individuals and entities listed, or parties that are determined to be owned or controlled by one or more individuals or entities listed, in Economic Sanctions and Export Control Laws.

Compliance with Anti-Trust, Anti-Corruption and Data Privacy Laws:

WARRANTY

Distributor List Prices

ASSA ABLOY ACCENTRA® (the "Company") warrants that its products sold under the ACCENTRA trade name in the United States of America & Canada are free from defects in work-manship and materials under normal use and service.

This warranty does not cover defects or damage arising from improper installation, lack of or improper maintenance, improper storage, shipping and handling, corrosion, erosion, ordinary wear and tear, misuse, abuse, accident, unauthorized service, or use with unauthorized non-ACCENTRA products or parts. This warranty is void if any modification is made to the product, regardless of whether the modification causes or contributes to the alleged defect. All modifications are made at the risk of the party making the modification.

The only liability of the Company in tort or contract whether under this warranty or otherwise shall be limited to the repair or replacement of any product or component part which shall prove defective as covered by this warranty, within the stated time frame listed below, after delivery to the original purchaser.

Electromechanical:

All components of electromechanical products are covered by a limited warranty period of one year after invoice date thereof of the original purchaser from us.

Keying Systems:

All bittings shall be originated or authorized by the ACCENTRA Key Systems Department to be compatible with one another in a specific type of cylinder (conventional, patented, security, high security, interchangeable core) and within a particular keying system.

Warranty for Cylinders Factory or Field Combined:

Cylinders shall be periodically lubricated depending on environmental conditions. Dry graphite, molybdenum disulfide or Polyube™ are recommended. Petroleum based liquid lubricants should only be used in cylinders in harsh or corrosive environments and should not be mixed with dry lubricants. Cylinder and/or core warranty will be voided if used in non-ACCENTRA locking devices.

Warranty for Cylinders Field Combined:

1. Keys shall be cut to the ACCENTRA key bitting specifications required for the particular keyway and depth system.
2. All pin lengths shall be selected according to prevailing factory standards.
3. Original ACCENTRA cylinders and cylinder components, including pin tumblers and key blanks, shall be used. We reserve the right to void the warranty if we deem that a malfunction is a result of non-original components which do not conform to ACCENTRA standards.

Product repair or replacement, or associated charges, will not be accepted under this warranty unless prior authorization from ACCENTRA has been given. Upon receipt of products returned for repair or replacement, we will determine whether products qualify for repair or replacement under this warranty. If they do not, we will obtain authorization prior to proceeding. We have no liability to pay any costs of repair performed by anyone other than qualified personnel authorized by ACCENTRA prior to the work being done.

The Company will not pay for the cost of repair performed other than in accordance with this warranty. Written notice of a product or component part believed to be defective as covered by this warranty should be sent to ASSA ABLOY ACCENTRA™, 225 Episcopal Road, Berlin, Connecticut 06037-4004, and should include your name and address, an identification of the product or component part and a brief description of the defect. Upon receipt of such notice, the Company will inform you where to ship such product or component part, shipping charges prepaid for examination and, in the event such examination reveals a defect covered by this warranty, the product will be repaired or replaced. The Company reserves the right to replace discontinued product with an equivalent product as deemed by the Company.

THIS WARRANTY IS IN LIEU OF ALL OTHER EXPRESS WARRANTIES. TO THE EXTENT PERMITTED BY LAW, ALL IMPLIED WARRANTIES ARE LIMITED TO THE DURATION OF THIS WARRANTY. ASSA ABLOY ACCENTRA® SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSIONS MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

Returned Goods

It is the policy of ACCENTRA to not accept returns of any materials that are correctly furnished as per the Distributor's Purchase Order. Return of product due to customer order error or accommodation must be pre-arranged with ACCENTRA and approved in writing by ACCENTRA Sales Management.

No Returns accepted for the following: Specials, Anything Used, Discontinued, Modified or Damaged Product, Electrical Products, Incomplete Products (e.g. missing keys, levers, roses, etc) or 10B Finished products.

All products returned as "Goodwill" must meet the following criteria to be considered a return:

- Be in original, unmarked and undamaged cartons.
- Be valued in excess of \$250.00 net.
- Shipped and invoiced within the previous 120 days.
- Can't be custom, non-cataloged goods, master-keyed or ACCENTRA Quick Ship Product or 10B Finished products. A MINIMUM reprocessing fee of 45% will be charged. Upon receipt and verification by ACCENTRA that the returned merchandise meets the foregoing conditions, a credit will be issued for the original invoice amount less the MINIMUM 45% reprocessing fee. "Goodwill" products that meet the foregoing criteria may be returned by fulfilling the following conditions:
- Send an RGA request in writing to the ACCENTRA Sales Representative serving the Purchaser's area.
- Ensure the RGA labels that are sent to Purchaser by ACCENTRA are visible on return goods shipment.
- Ensure that the RGA number appears on the return shipment label and is legible.
- Return the authorized merchandise within sixty (60) days from the date of RGA issuance date.
- Return shipments must be freight prepaid to the location specified on the RGA. ACCENTRA is not liable for damages to product during shipping. No credit may be taken or issued prior to RGA approval and receipt of product.

All defective goods within the terms of our limited warranty may be returned for credit or replacement.


